

## RESOLUTION 20-03

### INTERGOVERNMENTAL AGREEMENT CONCERNING STARCOM RADIO COMMUNICATION SYSTEM

AGREEMENT AND RESOLUTION made this 24<sup>th</sup> day of February, 2020, by and between the County of Jasper, Illinois, the City of Newton, Illinois and the Jasper County Emergency Telephone System Board ("911").

WITNESSETH:

WHEREAS, the Constitution of the State of Illinois and the Intergovernmental Cooperation Act, authorize units of local government to cooperate together to advantageously carry out the function of the respective units of local government for the common good of the Citizens thereof; and

WHEREAS, the Jasper County Sheriff's Office, the City of Newton Police Department, and the Jasper County Emergency Telephone System Board ("911") each utilize radio communication systems as an integral part of the delivery of law enforcement service and protection to the Citizens of Jasper County and the City of Newton; and

WHEREAS, presently each said law enforcement agency utilizes a radio system that they desire to upgrade; and

WHEREAS, the Jasper County Board, by and through its Sheriff, is willing and able to make the new radio system available to both the Office of the Jasper County Sheriff's Office and to the City of Newton Police Department and the Jasper County Emergency Telephone System Board ("911"); and

WHEREAS, there will necessarily be incurred an initial cost and monthly costs to get said radio system functioning and maintained; and

WHEREAS, the Jasper County Sheriff's Office, the City of Newton Police Department, and the Jasper County Emergency Telephone System Board ("911") each desire to utilize an upgraded radio system; and

WHEREAS, Jasper County by and through its Board and Chairman and the City of Newton, by and through its Council and Mayor and the Jasper County Emergency Telephone System Board ("911"), by and through its Chairman, believe it to be in the common good of the Citizens thereof to enter into this cooperative agreement.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY BOARD OF THE COUNTY OF JASPER AND THE CITY OF NEWTON, STATE OF ILLINOIS AND THE JASPER COUNTY EMERGENCY TELEPHONE SYSTEM BOARD ("911"), AS FOLLOWS:**

1. Jasper County, by and through its Sheriff, agrees to acquire for the Jasper County Sheriff's Office and the Newton City Police Department and the Jasper County Emergency Telephone System Board ("911") the STARCOM RADIO COMMUNICATION SYSTEM.

2. Jasper County, by and through its Board agrees to pay \$53,816.60 and the City of Newton, by and through its Council agrees to pay \$53,816.60, and the Jasper County Emergency Telephone System Board("911") agrees to pay \$12,657.18.

3. The parties' hereto understand and agree that the monthly fees associated with the use of radios and the STARCOM RADIO COMMUNICATION SYSTEM is the obligation of each agency based on usage.

4. The parties' hereto understand and agree that any future equipment needs or repair costs will be the responsibility of the agency with the need.

5. This agreement shall be effective beginning March 1, 2020 and shall terminate only upon the termination of the use of the STARCOM RADIO COMMUNICATION SYSTEM.
