Note 1-SALES TAX DEDUCTION ON BUILDING MATERIALS: A sales tax exemption is available for purchases of building materials within the State of Illinois, which will be permanently incorporated into real estate located in the Enterprise Zone. All such purchases must be made with the "EZ-1 Building Materials Exemption Certification" issued by the Illinois Department of Revenue. Building Materials Exemption Certificate (BMEC) Holders are required to report to the Illinois Department of Revenue annually and within 60 days after completion of the project. Failure to report may result in being barred from securing certificates for other enterprise zone projects. Reporting is required for any year that the certificate is approved. PLEASE see information for sales tax: IL Dept. Revenue Regulation "Title 86, Part 130 ("Retailers Occupation Tax") or call IL Department of Revenue, Legal Services Bureau (Springfield Office) 217-782-7054. You must have an IDOR issued certificate prior to the start of construction to qualify for any incentives. A business cannot be both a retailer and a contractor in the same transaction. Upon expiration of the zone, all incentives and benefits will cease.

Note 2- So long as the Company maintains a direct interest in the Project or any part thereof, the Company agrees to indemnify and save the City and its officers and employees harmless against all claims by or on behalf of any person, firm or corporation arising from the project.

Note 3- The Company must comply with all laws.
