ORDINANCE NO. 25-09

AN ORDINANCE TO AMEND THE ZONING MAP OF THE
ZONING CODE TO THE
CITY OF NEWTON, JASPER COUNTY, ILLINOIS

WHEREAS, a public hearing was held on May 13, 2025 at 6:00 o'clock p.m. before Zoning Board of Appeals and notice of said hearing was duly given; and

WHEREAS, a request to change Zone District Classification was presented requesting amendment to the Zoning Code as set forth on Exhibit A, attached hereto and incorporated herein by this reference; and

WHEREAS, the Corporate Authorities of Newton, Illinois concur in the aforesaid findings and recommendations of the Zoning Board of Appeals.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEWTON, ILLINOIS:

Section 1: Amendments. The proposed Zoning Amendment to change the Zone District Classification of the properties described in Exhibit B attached, is hereby granted changing the Zone Classification of the described properties from B-1 to SR-2.

Section 2: Severability of Provisions. Each section, paragraph, sentence, clause and provision of this Ordinance is severable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of the Ordinance, nor any part thereof, other than that part affected by such decision.

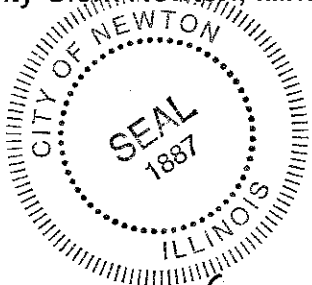
Section 3: Effective. This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.

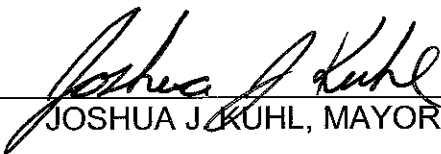

ADVISORY REPORT REQUEST FOR ZONING MAP AMENDMENT

TO THE MEMBERS OF THE NEWTON CITY COUNCIL:

A public hearing was held on Tuesday, May 13, 2025 in the City Hall chambers by the Zoning Board of Appeals to consider an amendment to the City of Newton zoning ordinance.

The request from the Jasper County Community Unit #1 is to amend the zoning district classification for the properties at **Parcel Number:** 90-12-02-204-003, PT SW 1/4 NE 1/4 S2 T6 R9 21.14 AC NEWTON COMMUNITY HIGH SCHOOL B 187 P 749; B 197 P 419; ESMT B 235 P 555; **Parcel Number:** 90-12-02-210-001, LOTS 1 & 2 BLOCK 12 FALLERS ADDITION TO CITY OF NEWTON NEWTON COMMUNITY HIGH SCHOOL B 78 P 305; B 81 P 154; B 92 P 505; B 121 P 272; **Parcel Number:** 90-12-02-214-001, LOTS 1 & 2 BLOCK 11 FALLERS ADDITION TO CITY OF NEWTON NEWTON COMMUNITY HIGH SCHOOL B 78 P 305; B 81 P 154; B 92 P 505; B 121 P 272; from a Neighborhood Business B-1 district to a Single Family Residence (Small) SR-2 district.

After considering the testimony presented at the hearing, the Zoning Board of Appeals recommends by a 5-0 vote that the properties be rezoned from a Neighborhood Business classification to a Single Family Residence classification.
