However, she reported that the area is experiencing increased traffic, speeding vehicles, and the gate is not being secured as originally proposed. Mayor Kuhl reminded Donna the baseball tournament season was almost over and the gate would be locked. The city will explore options for removable speed bumps and will have the police department increase patrols in the area and monitor the gate to ensure it is being properly secured.
